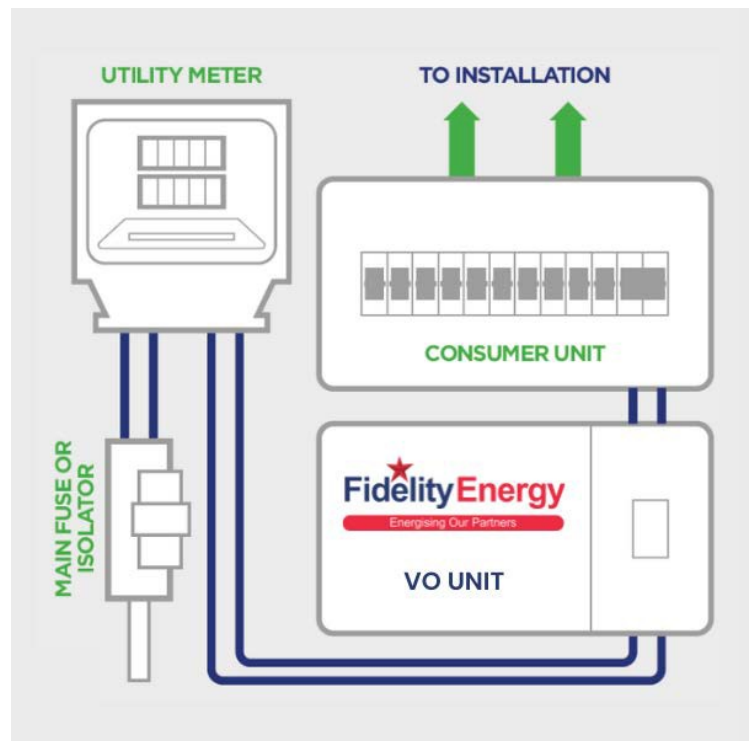
VOLTAGE OPTIMISATION
